Summary

Point 2	<p><u>WG1</u>: The high level framework is in discussion within the ENTSOs. The SRG will be informed of the results after its finalization. For the upcoming discussion on the use of flexibilities the ENTSOs explain the differences between the expansion and the dispatch model which allows hourly flexibilities to be taken into account. A questionnaire is planned for a more detailed district heating planning, SRG will be asked to contribute. The updated detailed timeline for the 2026 process is in preparation and will be distributed to the SRG.</p> <p><u>WG2</u>: The members of the WG asked ENTSOE for a presentation of the DFT (demand forecast tool) to understand the demand forecasting methodology for the different customer groups and the steps taken with the imported ETM data. Particularly, the design and logic of the various profiles for the demand sectors are of main interest, as they will influence the assessment of the flexibilities. The WG offers support with the assumptions and profiles for the EV modelling in the DFT.</p> <p><u>WG3</u>: A workshop is planned to discuss the potential flexibility delivered by heat pumps to the electricity system.</p> <p><u>WG4</u>: No updates, as the Innovation Roadmap Document has not been published yet.</p>
Point 3	<p>The ENTSOs plan a public webinar to inform the public on the final Innovation Roadmap Document, after its publication. The involvement of the SRG will be discussed as soon as the Innovation Roadmap is ready.</p>
