Summary

Point 2	<p><u>WG1</u>: Next meeting planned on the 19th of November 2024 will be dedicated to the planning of the 2025 working priorities, defining key topics and priorities of work, incl. potential timelines. All SRG members and observers are invited to join. One aim of the meeting is to suggest an assignment of the topics and tasks to the SRG members and alternates.</p> <p>The detailed overall timeline is planned to be finished by the ENTSOs until the 15th of November 2024. The Innovation Roadmap Document is nearly finished, but the decisive board meetings of the ENTSOs will take place in December. Publication date is planned for end of December. After the final approval an additional data collection round with the national TSOs will start.</p> <p><u>WG2</u>: The WG is working with Quintel on the changes in the ETM regarding the building and household reference data, Eurostat data 2019 and heating calculations.</p> <p><u>WG3</u>: On the 18th of November 2024 the workshop on flexibility and biomethane is organized together with the specialists of the ENTSOs on the DFT and Plexos tools.</p> <p><u>WG4</u>: Ongoing discussion on the modelling of CO₂ within the ENTSOs tools. As soon as the Innovation Roadmap is published and shared with the SRG, the work will pick up again.</p>
Point 3	<p>Many of the SRG members already updated their expertise and Working Groups' affiliation in the table on sharepoint. Thank you for the effort.</p> <p>There will be an additional column indicated in the file related to the SRG Membership, indicating where each of the SRG member is located, so that this could make the planning of in-person workshops and meetings easier.</p>
Point 4	<p>ENTSOs suggested a workshop for SRG members and observers planned for the 2nd week of December to discuss the decisions of the ENTSOs on the high-level framework and economic variants, the Innovation Roadmap Document and the overall timeline. ENTSOs will come up with some dates.</p> <p>A public workshop on these topics will be organised in February.</p>
